# Methodology and Sample

#### Sample selection

The opt-in online survey link was made available by the Lithgow City Council. 168 participants completed the full survey.

#### Data analysis

The data within this report was analysed using Q Professional. All percentages are calculated to the nearest whole number and therefore the total may not exactly equal 100%.

Comparisons are also made to the results from a phone survey of 601 randomly selected residents.

#### **Important Note**

As this survey data is from a self select sample, the results are only reflective of those who have participated, and cannot be generalised across the broader population.

#### **Ratings** questions

The Unipolar Scale of 1 to 5 was used in all rating questions, where 1 was the lowest support or concern and 5 the highest support or concern.

Top 2 Box (T2B): refers to the aggregate percentage (%) score of the top two scores (i.e. agree and strongly agree, concerned and very concerned, etc.)

# **Engagement Objectives**

×

In September 2024, Lithgow City Council conducted a representative telephone survey of residents living in the Lithgow Local Government Area.

The results of this research have been reported separately.

For engagement purposes, Council also provided the community an opportunity to self complete the survey. An online link was made available on Council's website and across social media channels.

#### Why?

• To provide the community with an engagement opportunity around perception of Council's performance, quality of life, liveability statements, interaction with Council and community priorities.

#### How?

• N=168 completed online surveys

#### When?

The link was open from 25<sup>th</sup> September to 6<sup>th</sup> October 2024

# **Summary Findings**



77% of Online respondents rated their quality of life as 'good' to 'excellent' – compared to 85% of Phone respondents

#### What do Online respondents want prioritised?

- 53% Economic development
- 24% Roads
- 23% Infrastructure/services/facilities
- **20%** Environment (renewables/ sustainability/ etc.)
- **12%** Supporting tourism

Prepared to respond to significant shocks/ stressors



94% of Online respondents feel at least somewhat prepared to respond to shocks and stressors – in line with Phone respondents.

What are Online respondents most concerned with? (Q6 – Short term/sudden and everyday pressures)

- 86% Bushfires
- 86% Demand on roads
- 86% Investment in infrastructure
- **78%** Limited capacity of local councils
- 76% Lack of opportunities for young people



#### What do Online respondents love the most?

- 49% Natural environment
- 40% Sense of community/ friendly people
- 21% Relaxed lifestyle/ peaceful
- 20% Convenient/ central location

# **Quality of Life**

Compared to Phone respondents, Online respondents rated their quality of life living in the Lithgow City LGA lower, with 77% rating their quality of life as 'good' to 'excellent'.

Younger residents, non-ratepayers and those who identify as living with disability rated their quality of life lower.

### **Agreement with Liveability Statements – Highest / Lowest**

In terms of highest and lowest levels of agreement for liveability statements, Online results are generally in line with Phone. Online respondents showed higher agreement for safety and sense of community and lower for economic planning and growth.

Online respondents expressed low levels of agreement with Health and Infrastructure measures, with more than 50% disagreeing with Infrastructure and Development criteria. Compared to Phone respondents, the largest gap in agreement is for sewer infrastructure (21% agree cf. 39%).

Looking again at the difference in agreement and disagreement for liveability statements for Online and Phone respondents.

Online respondents tend to be much more negative compared to Phone respondents for Infrastructure and Development. Notably, Online respondents rated the reliability of sewer infrastructure significantly lower (51% negative) compared to Phone respondents (30% negative).

Top 2 box scores of 5% or less was seen for sufficient planning for economic growth and development, young people able to get a local job, long-term future planning and the local economy ready for the future.

Within the Services and Facilities pillar, agreement was highest for 'living in Lithgow gives you a sense of living in a community' (55%) and lowest for 'there is a good range of leisure and recreation opportunities' (29%). Compared to Phone respondents, Online respondents are less likely to agree with most statements, particularly regarding the value and preservation of heritage.

Economic development, roads, infrastructure and services and environmental aspects remain high priority issues for online respondents. They placed a higher level of priority on environmental aspects and tourism compared to Phone residents.

# **Support for Future Projects and Initiatives**

Support is highest overall for developing more employment opportunities for young families in the area, with 87% of Online respondents supportive/very supportive (74% commitment to the top box 'very supportive'). Online respondents are notably less supportive of Council attracting larger retailers to the area than Phone respondents.

#### **Environmental Issues**

71% of Online respondents stated they have experienced extreme weather events in the last 2 years. Compared to Phone respondents, Online respondents were less likely to state they have experience poor air quality (30% cf. 45%).

Rural residents were more likely to have experienced extreme weather events in the last 2 years.

# Concern for Short-term / Sudden Shocks and Stresses

In terms of short-term or sudden events, 60% of Online respondents are 'very concerned' about bushfires. Compared to Phone respondents, Online respondents are notably more concerned about a lack of water and bushfires.

Rural residents are more concerned about heatwaves, whilst those in Lithgow are more concerned about floods. Those aged over 50

are more likely to be concerned about a 'lack of water security' and males are less concerned across the majority of shocks and Online Phone stresses. # **Concern for Everyday Pressures**

In terms of everyday pressures, Online respondents are most concerned with the demand on roads (86%) and investment in infrastructure (86%). Compared to Phone respondents, Online respondents have a greater level of concern for the limited capacity of local councils and declining social cohesion.

# **Preparing for Significant Shocks and Stressors**

96% of Online respondents feel at least somewhat prepared to respond to shocks and stressors, with 54% feeling prepared/very prepared – in line with Phone.

Those residing in Lithgow feel significantly less prepared to respond to significant shocks and stressors than outer areas.

# Support in a Crisis

More than 50% of Online respondents feel able to seek support from a neighbour, friend or family member. Online respondents feel less able to ask for support in a crisis compared to Phone respondents.

In order to promote a sustainable recovery after natural disaster or pandemic, Online respondents are most supportive of the provision of clean, safe water, promoting local employment, and improving access to health services/precincts. More than 50% of Online respondents are supportive/ very supportive of all sustainable recovery projects and initiatives.
